3. The report of the Government of Rajasthan has been considered in this Department and based on the report submitted by the State Government, the competent authority has decided to de-blacklist the organization. Accordingly, the organization, 'Nirashrit Mahila Bal Vikas Gramodyog Shiksha Samiti', Bharatpur District, Rajasthan, is hereby de-blacklisted with immediate effect.
